**FIRM NAME PARTNER OF HAYES-SOLOWAY LAW FIRM DECEASED**

Oliver Wolcott “Pat” Hayes, 92, firm name partner of Hayes Soloway, P.C., an intellectual property boutique with offices in Tucson, Arizona and Manchester, New Hampshire, died November 29, 2007, from complications following surgery. He had been practicing in the patent profession for more than 60 years and had vast experience in patent prosecution, litigation and licensing. In addition, he counseled clients and rendered formal opinions concerning the infringement/noninfringement of patents, the validity/invalidity of patents and the designing of products and processes to avoid potential patent infringement.

Mr. Hayes obtained his B.S.E. degree in physics and electrical engineering from Brown University and his J.D. from George Washington University Law School. He was a member of the Bar of the District of Columbia and the Commonwealth of Massachusetts, and was registered to practice before the United States Patent and Trademark Office.

He was a U.S. Navy veteran of World War II, and later worked briefly at MIT, then joined Polaroid as counsel to Dr. Edwin Land. He was Chief Patent Counsel for National Research Laboratories and Chief Patent Counsel for the Norton Company. In the late

1970s, he joined the law practice of Nick Soloway, Esq., in Manchester, New Hampshire and the firm name became Hayes Soloway, P.C.

Mr. Hayes is a past president of the Boston Patent Law Association, past president of The Association of Corporate Patent Counsel, a member of the Advisory Council of the PCT Research Foundation, and served as a judge in moot court competitions at the Franklin Pierce Law Center.
